Paris Beacon, 21 or 22 May 1947 - "Mrs. Aggie Hickel, 77, was found dead at her home, 311 East Jackson Street, late Wednesday afternoon by her son Clayton. Coroner Albert H. Lycan conducted an inquest this morning at the Cok and Ward Funeral Home, the jury returning a verdict that her death was due to a heart attack. The deceased was born in Indiana on July 22, 1869, a daughter of William and Nancy Jane Roberts Bales. She was a small child when her parents came to Edgar County. Two years ago she moved to Paris from a farm northeast of the city. Her husband, Jacob Hickel, to whom she was married in 1897, passed away three years ago. Surviving are three children, Mrs. Roy Williams of Martinsville, IL, Clayton and Archie Hickel, both of Paris, also fourteen grandchildren and two great-grandchildren. Funeral rites will be conducted at two o'clock Friday afternoon at the Cook and Ward Funeral Home and burial will be at Franklin Cemetery."

The Paris Daily Beacon - Page 2 - July 15 1905 - "Sudden Death Of Young Child" "Three Year Old Daughter Of Mr. And Mrs. James Hichel Expires Suddenly" "The bright little three year old daughter of Mr. and Mrs. James Hichel of Baldwinsville, passed away at 3 o'clock this morning, after a brief illness of a few hours. The child suffered from an attack of dysentery. Funeral arrangements are not yet completed. A sad feature of the case was the birth of a little daughter to Mr. and Mrs. Hichel a short while after the demise of their daughter. The mother is in a serious condition." (*Note from Jeff Wallace. Although this article is laced with inaccuracies, including the name Hichel and the birth of a daughter (was actually a boy), it backs up statements made by Melva Bell. Melva stated that story was that Bessie ate a bunch of green apples making her ill. This could cause dysentery.)

Mr. Hickel was born October 13, 1871, in Edgar Township, the son of Nancy Caskey and Martin Hickel.
